Textual Information()	<p>The Company's following two promoter's shareholding are not in demat form: 1. M/s SBEC Systems Limited (U.K.) holding 2040000 equity shares (approx. 20.4% of the total paid-up capital of the Company) The Company was on final stage of getting approval of revocation of suspension of equity shares, in this respect, the company had hired a consultant in United Kingdom and requested them to provide the status of the shareholder. On the basis of information and dissolution certificate, provided by the consultant it was gathered that the shareholder was dissolved on 19th June, 2001 and as per Gazette Notice dated June 19, 2001 issued by the Registrar of Companies (UK) that upon dissolution all property and rights vested in, or held on trust for the Company are deemed to be bona vacantia, and accordingly will belong to the crown. SBEC Systems (India) Limited (Company), has not received any communication from the SBEC Systems Limited (UK) (shareholder) and nor the shareholder has attended any of the general meetings conducted by the Company for the past several years. 2. Ms. Meghna Modi holding 200 equity shares. The Company was suspended from the stock exchange since 2001 due to penal provisions. M/s SBEC Systems (India) Limited vide letter dated February 20, 2016 initiated the process of revocation of suspension of shares of the Company, one of the pre-condition for revocation of suspension of equity shares was to lock in the entire shareholding of promoters upto 31st March, 2020. Subsequently, after complying with all the formalities with the BSE, the Company had received approval for revocation of suspension in trading of equity shares from the BSE on 23rd December, 2019. With regards to shareholding of Ms Meghna Modi (holding 200 equity shares in physical form), the Company has approached the Depository Participant but due to COVID19 Pandemic they are not accepting the shares for dematerialisation because Courier Services is not available. Hence we can demat the shares of Ms. Meghna Modi only after Depository Participant will start to accept the shares for dematerialisation</p>
